The attached resolution appropriates an additional four hundred thousand dollars (\$400,000) in Room Tax revenue of which three hundred thirty-two thousand five hundred dollars (\$332,500) is appropriated to the Convention Center Operating Reserve Fund (202), and sixty-seven thousand five hundred dollars (\$67,500) is appropriated to the Office of Economic and Community Development Areawide General Fund (101). This resolution provides the level of appropriation necessary to support payments required under the professional services contract with the Anchorage Convention Center & Visitors Bureau (ACVB) and the Use Agreement with CIVICVentures.

The revised Room Tax forecast is based on year-to-date revenue trends through the 3<sup>rd</sup> quarter of 2006, and an additional boost from the Alaska Federation of Natives Convention that was held in Anchorage in October. Total Room Tax revenue projected to be received in 2006 exceeds 2005 levels by 7.3%.
