1 AN ORDINANCE SUBMITTING TO THE QUALIFIED VOTERS RESIDING IN THE BEAR
2 VALLEY LIMITED ROAD SERVICE AREA (LRSA) AT THE REGULAR MUNICIPAL
3 ELECTION ON APRIL 4, 2006, A BALLOT PROPOSITION TO EXTEND THE BEAR
4 VALLEY LIMITED ROAD SERVICE AREA (LRSA) FOR AN ADDITIONAL THREE
5 YEARS AND AMENDING ANCHORAGE MUNICIPAL CODE SECTION 27.30.370.

8 WHEREAS, the Bear Valley Limited Road Service Area (LRSA) was created by Anchorage
9 Ordinance 88-99; and

10
11 WHEREAS, a showing of interest in extending the Bear Valley LRSA has been made by the
12 residents of the LRSA; and

13
14 WHEREAS, the Bear Valley LRSA Board of Supervisors recommends the extension of the LRSA
15 for three additional years; now therefore,

16
17 THE ANCHORAGE MUNICIPAL ASSEMBLY ORDAINS:

18
19 **Section 1.** Pursuant to Anchorage Municipal Charter 9.01(a), a ballot proposition in
20 substantially the following form shall be submitted to the qualified voters residing in the Bear
21 Valley LRSA at the regular Municipal election April 4, 2006:

25 APPROVING THE EXTENSION OF THE BEAR VALLEY LIMITED ROAD
26 SERVICE AREA FOR THREE ADDITIONAL YEARS.

28 Shall the Bear Valley Limited Road Service Area be extended for three additional
29 years until December 31, 2009?

34 **Section 2.** Anchorage Municipal Code section 27.30.370 is hereby amended as follows:

36 27.30.370 Bear Valley Limited Road Service Area

38 A. There is established, pursuant to section 9.01 of the Charter, a limited road service
39 area within the municipality to be known as Bear Valley Limited Road Service
40 Area of the municipality, as outlined on the map located in section 27.30.700.

42 B. The Bear Valley Limited Road Service Area shall contribute funds expressly for
43 maintenance of roads and snow plowing, commencing on January 1, 1989, and

1 ending on December 31, 2009 [2006], unless the service area is extended by an
2 affirmative vote of the area affected at the regular election in April 2009 [2006].
3 The mill rate shall not exceed 1.50 mills in any calendar year.

8 **Section 3.** Except for Section 2, this ordinance shall become effective upon passage and
9 approval of the Anchorage Municipal Assembly. Section 2 and the proposition contained in
10 Section 1 shall become effective upon certification of the regular election on the proposition called
11 for by this ordinance, but only if the proposition is approved by the majority of the qualified voters
12 voting on the proposition.
