<u>Section 2.</u> Anchorage Municipal Code section 27.30.610 is amended to read as follows:

### 27.30.610 Totem Limited Road Service Area.

- A. There is a limited road service area within the municipality known as the Totem Limited Road Service Area (TLRSA) to provide limited road maintenance to the area described on the map located in section 27.30.700.
- B. The Totem Limited Road Service Area shall contribute funds expressly for the maintenance of roads commencing on July 1, 1993, and shall continue in existence until altered or abolished [END ON DECEMBER 31, 2007, UNLESS THE SERVICE AREA IS EXTENDED] by an affirmative vote of the [SERVICE] area affected at an election held prior to the alteration or abolishment of the service area [THE REGULAR ELECTION OF APRIL 2007]. The mill rate shall not exceed 1.50 mills in any calendar year.
