<u>Section 2.</u> Anchorage Municipal Code section 27.30.340 is amended to read as follows:

27.30.340 Upper Grover Limited Road Service Area.

- A. There is a limited road service area within the municipality known as the Upper Grover Limited Road Service Area to provide limited road maintenance and repair to the area described on the map located in section 27.30,700.
- B. Limited road service maintenance and repair within the service area shall commence on January 1, 1984, and shall continue in existence until altered or abolished [END ON DECEMBER 31, 2007, UNLESS THE SERVICE AREA IS EXTENDED] by an affirmative vote of the [SERVICE] area affected at an election held prior to alteration or abolishment of the service area [THE REGULAR ELECTION OF APRIL 2007]. The mill rate shall not exceed 1.0 mill in any calendar year.
