PUBLIC SECTOR ECONOMIC EFFECTS:

This is the eighth and final five-year renewal option for Lots 8-B and 8-C for Anchorage Fueling and Service Company. The per square foot charge is increased from \$0.73 to \$0.85 per square foot for the term commencing March 5, 2007 and ending March 4, 2012. The increase in the lease rate results in an increase of annual rent from \$357,100 to \$413,128, yielding \$56,028 in new revenue for this 5-year renewal option.

Shell Oil Company (Shell) and the Municipality of Anchorage (then City of Anchorage) entered into a Lease agreement (Lease) on January 19, 1962 for Parcel B and Lot 8, Port of Anchorage Subdivision. The term of the Lease was for Ten (10) years with Eight (8) Five (5) year options.

The Lease was amended on or about July 11, 1973 to rename Parcel B to Lot 8-B and Lot 8 to Lot 8-C, pursuant to recorded plat #71-0032.

A Consent to Assignment and Amendment of Lease was signed on May 29, 1981, consenting to the assignment of the lease from Shell to Anchorage Fueling and Service Company (AFSC). The amendments included Article Second to include an outside appraisal option in the event the parties could not agree on new terms; Article Eighth which updated the hold harmless clause; Article Fifteenth added a requirement for Workmen's Compensation and employer's liability coverage; and Article Twenty-third clarifying where and to whom notices are to be sent.

AFSC has remitted notification of its desire to exercise the eighth and final Five (5) year option beginning March 5, 2007 and ending March 4, 2012. The Port of Anchorage has notified AFSC that in 2005, selected parcels were appraised to establish Fair Market Rental Rates for lease renewal options exercised by Totem Ocean Trailer Express and Horizon Lines effective January 1, 2006. Of the nine parcels appraised, Lot 6C-1 is similar in amenities to Lots 8-B and 8-C. The Fair Market Rental Value established by the Appraiser was \$0.85 per square foot. Based on that 2005 appraisal information, the Port proposes to increase the annual rental from \$357,100.00 to \$413,128.00 effective March 5, 2007. This increases the square foot rate from \$0.73 to \$0.85 per square foot.
