Over the last few years, organized labor has become more diligent in its attempts to accrete non-represented employees into the Union, including employees traditionally exempt from collective bargaining because of specific exclusions from bargaining in Anchorage Municipal Code section 3.70.060. Due to reorganizations and the delegation of authority to non-excluded departments, the departmental exclusion no longer covered the affected positions, even though there have been no changes to duties or functions.

The ordinance clarifies those positions and functions continue to be exempt even if removed from the excluded department and assigned to a department without the exemption.

21 22 In addition, the ordinance excludes the Office of Management and Budget and the Office of Emergency Management. Traditionally, these offices were excluded from bargaining when organized under the Municipal Manager's office, due to the sensitive nature of information prepared in the normal course of business, and this is an appropriate opportunity to clarify these historic exemptions.
