

AN ORDINANCE AUTHORIZING WITHDRAWAL OF HERITAGE LAND BANK (HLB) PARCELS #4-014, 4-015 AND 4-016 FROM THE HLB INVENTORY AND TRANSFER TO THE REAL ESTATE SERVICES DIVISION WHEREAS, pursuant to Anchorage Municipal Code section 25.40.010, "It is the mission of the Heritage Land Bank to manage uncommitted municipal land and the Heritage Land Bank Fund in a manner designed to benefit the present and future citizens of Anchorage..."; and WHEREAS, the Heritage Land Bank inventory includes three parcels underlying the John Thomas Building and other improvements located on the northeast corner of 3rd Avenue and Cordova Street, legally described as Lots 9, 10 and 11A, Block 37B, East Addition; and WHEREAS, the John Thomas building and related improvements upon the three parcels is under management authority of the Real Estate Services Division; and WHEREAS, on February 8, 2006, after completing an agency review and public noticing of the proposed action, the Heritage Land Bank Advisory Commission approved Resolution 2007-02, recommending withdrawal of the three subject parcels from the Heritage Land Bank inventory for transfer to the Real Estate Services Division; now, therefore. THE ANCHORAGE ASSEMBLY ORDAINS: Section 1. Heritage Land Bank (HLB) Parcels #4-014, 4-015 and 4-016 shall be withdrawn from HLB inventory and transferred to the Real Estate Services Division. Heritage Land Bank (HLB) Parcels #4-014, 4-015 and 4-016 are three lots comprising the John Thomas Building and paved parking areas located on the northeast corner of Cordova Street and East 3rd Avenue (see map, Appendix A). They are legally described as follows:

HLB Parcel #4-014 – Lot 9, Block 37B, East Addition (TID #002-083-33) HLB Parcel #4-015 – Lot 10, Block 37B, East Addition (TID #002-083-32) HLB Parcel #4-016 - Lot 11A, Block 37B, East Addition (TID #002-083-30)

Parcels #4-014 and 4-015 are 7,000 square feet each in area, and Parcel #4-016 is 14,000 square feet. All are zoned R-0. Currently, the building located on the properties is leased for use by non-profit agencies, and is under management authority of Real Estate Services (RES).

Pursuant to the Heritage Land Bank's mission statement in Anchorage Municipal Code section 25.40.010, HLB is responsible for the management of 'uncommitted land'. In addition, the improvements on the properties, as well as the management of the improvements, fall under another municipal agency (RES).

The Administration recommends the identified properties be transferred to Real Estate Services as a means for providing management authority of the land as well as its improvements under one municipal agency. This requires the removal of those properties from the HLB inventory.

On February 8, 2007, the Heritage Land Bank Advisory Commission approved HLBAC Resolution 2007-02 (Appendix B), recommending the Assembly to approve the withdrawal of these three parcels from the HLB inventory for subsequent transfer to Real Estate Services.



A RESOLUTION OF THE HERITAGE LAND BANK ADVISORY COMMISSION RECOMMENDING ASSEMBLY APPROVAL TO WITHDRAW HLB PARCELS 4-014, 4-015 AND 4-016 FROM THE HLB INVENTORY, FOR TRANSFER TO REAL ESTATE SERVICES

WHEREAS, "It is the mission of the Heritage Land Bank to manage uncommitted municipal land ... to benefit the present and future citizens of Anchorage, promote orderly development, and achieve the goals of the comprehensive plan." (AMC 25.40.010); and

WHEREAS, "... the Heritage Land Bank may, at the direction of the Mayor and Assembly, withdraw and transfer to municipal agencies or to the school district, land from the Heritage Land Bank inventory needed for the location of public facilities or purposes..." (AMC 25.40.010.D); and

WHEREAS, the three parcels, located on the northeast corner of West 3rd Avenue and Cordova Street, have a building and other improvements upon them that are currently under management authority of Real Estate Services,

NOW THEREFORE BE IT RESOLVED, THAT:

Section 1. The Heritage Land Bank Advisory Commission approves the withdrawal of HLB Parcels 4-014, 4-015, and 4-016 from the inventory, and transfer to Real Estate Services for management of the land as well as improvements.

Section 2. This resolution shall take effect immediately upon passage and approval.
