AN ORDINANCE SETTING THE RATES OF TAX LEVY, APPROVING THE
AMOUNT OF MUNICIPAL PROPERTY TAX, AND LEVYING TAXES FOR ALL
SERVICE AREAS OF THE MUNICIPALITY OF ANCHORAGE GENERAL
GOVERNMENT FOR FISCAL YEAR 2007

THE ANCHORAGE ASSEMBLY ORDAINS:

Section 1. The Assembly hereby fixes the rates of tax levy for all service areas of the
Municipality of Anchorage general government for fiscal year 2007. The Anchorage
Assembly levies these taxes upon the full value of all assessed taxable real and personal
property as follows:

Section 2. Areawide General a tax of 0.23 mills

Section 3. City Service Area a tax of 0.02 mills

Section 4. Anchorage Fire Service Area a tax of 1.73 mills

Section 5. Anchorage Roads & Drainage Service Area a tax of 2.59 mills

Section 6. Anchorage Metropolitan Police Service Area a tax of 2.60 mills

Section 7. Anchorage Parks & Recreation Service Area a tax of 0.60 mills

Section 8. Girdwood Valley Service Area a tax of 4.00 mills

Section 9. Eagle River-Chugiak Parks & Recreation Service Area a tax of 1.11 mills

Section 10. Chugiak Fire Service Area a tax of 1.00 mills

Section 11. Chugiak, Birchwood, Eagle River Rural Road
Service Area a tax of 1.85 mills

Section 36. The property tax amount approved for 2007 (within the meaning of the tax increase limitation ("tax cap") provision of the Charter, Section 14.03) is \$203,926,060.

Section 37. The total amount of property taxes levied for all service areas of the Municipality of Anchorage general government for fiscal year 2007 is:


