SUBJECT: AN ORDINANCE SETTING THE RATE OF TAX LEVY, APPROVING

THE AMOUNT OF MUNICIPAL PROPERTY TAX, AND LEVYING TAXES FOR THE ANCHORAGE SCHOOL DISTRICT FOR TAX YEAR

This memorandum transmits the ordinance to establish the 2007 tax rate and tax levy for the Anchorage School District. The Anchorage School District (ASD) tax rate and tax levy are based on the amount of property taxes required to support the ASD operating budget in calendar year 2007. These reflect one half of the property taxes required for ASD's revised fiscal year 2006-2007 operating budget, and one half of the property taxes required for ASD's fiscal year 2007-2008 operating budget.

The property tax shown in AO 2007-67(S) reflects ASD's revised debt service requirements for FY 2007-2008 based on voter approval on April 3, 2007 of two education-related general obligation bond propositions and refunding of bonds in April 2007 (see AR 2007-91(S) and accompanying memorandum AM 263-2007(A)).
