

ASSEMBLY AMENDING AMC SECTION 1.15.020, PROHIBITED CONDUCT, TO PROHIBIT THE CONDITIONING OF OFFICIAL ACTION ON THE RETENTION OR NON-RETENTION OF SERVICES OF A

THIRD PARTY.

If enacted, AO 2007-74 would amend the Code of Ethics (AMC 1.15) to prohibit elected officials or municipal employees from misusing their office by conditioning official action on who persons having business before the municipality utilize for professional services, supplies, construction. The ordinance targets unethical influence peddling used to secure economic advantage for private businesses in their dealings with municipal contractors or other entities in matters before the municipality or administration.

AO 2007 does not prohibit municipal officials from taking action authorized by law in procurement activities or statements made by elected officials in official proceedings of legislative bodies if subject to the legislative privilege.

Enactment of AO 2007-74 is recommended.
