AN ORDINANCE AMENDING ANCHORAGE MUNICIPAL CODE SECTION 2.50.030 TO REQUIRE USE OF STANDARD LETTER-SIZE (8.5" X 11") PAPER FOR A MASTER PETITION AND, IF REQUESTED, THE NAME AND MAILING ADDRESS OF A SPONSOR ON THE MASTER PETITION AND AUTHORIZING TECHNICAL CLARIFICATIONS TO PROPOSITIONS SUBMITTED.

THE ANCHORAGE ASSEMBLY ORDAINS:

**Section 1.** Anchorage Municipal Code section 2.50.030B. is amended to read as follows  
(the remainder of the section is not affected and therefore not set out):

**2.50.030**      **Certification of application.**

B. *Master form of petition.* Upon certification of the application, the municipal clerk shall provide a master form of the petition to the primary contact person. Only unaltered photocopies of this master form may be used to gather signatures. The municipal clerk shall not be responsible for reproducing copies of this master form. The master form of the petition shall contain the proposition and title as submitted by the sponsors and shall [STATE]:

1. State t[T]he date of first actual circulation of the petition as designated by the municipal clerk; [and]
2. state [THAT] the signatures on the petition must be secured within 90 days from the date of first actual circulation;
3. contain an affirmation in a form acceptable to the Department of Law;
4. be printed on standard white letter-size (8.5"x 11") paper;
5. include, if requested at the time an application is filed, the name and mailing address of a sponsor or sponsoring organization to receive completed petitions before they are filed with the Clerk; and
6. contain those technical corrections the Department of Law, as Revisor of Ordinances may recommend.
