AN ORDINANCE AMENDING ANCHORAGE MUNICIPAL CODE SECTION 4.60.090. PARKS AND RECREATION COMMISSION, AND AMC 4.60.190, PUBLIC FACILITIES ADVISORY COMMISSION, AND AMC 21.15.133, APPROVAL OF STREET NAME ALTERATIONS, TO MAKE CORRECTIONS IN CONFORMITY WITH ADOPTION OF ANCHORAGE MUNICIPAL CODE CHANGES ON NAMING PUBLIC PLACES.

THE ANCHORAGE ASSEMBLY ORDAINS:

Section 1. Anchorage Municipal Code section 4.60.090, Parks and Recreation Commission, is hereby amended to read as follows:

4.60.090 Parks and recreation commission.

The commission shall act in an advisory capacity to the mayor and assembly in all matters pertaining to parks and recreation, including but not limited to:

E. Advising the citizen's naming panel [PUBLIC FACILITIES ADVISORY COMMISSION] on selections of names for park sites and park or recreation facilities under the provisions of Chapter 3.97 [IN RECOMMENDATIONS TO THE MAYOR FOR ASSEMBLY APPROVAL].

21.15.133 Approval of street name alterations.

A. Generally. A street name alteration may be proposed by a government agency or by petition. The proposal or petition shall be submitted to the department of public works. The department of public works shall reject any street name alteration that does not conform to the standards of Section 21.80.260 and any regulations promulgated thereunder. The criteria established in AMC 3.97.025[C] for honorary renaming shall apply.
