Section 3. Anchorage Municipal Code section 21.15.133, Approval of Street Name Alternations, is hereby amended to read as follows:

21.15.133 Approval of street name alterations.

A. *Generally.* A street name alteration may be proposed by a government agency or by petition. The proposal or petition shall be submitted to the department of public works. The department of public works shall reject any street name alteration that does not conform to the standards of Section 21.80.260 and any regulations promulgated thereunder. The criteria established in AMC 3.97.025[G] for honorary renaming shall apply.
