WHEREAS, the Anchorage Assembly approved Assembly Ordinance 2004-124(S) on
September 21, 2004, establishing the Cooperative Services Authority; and

WHEREAS, Cooperative Services Authority is an instrument of the Municipality of
Anchorage, but exists independently of and separate from the Municipality; and

WHEREAS, 2008 operating budget for the Cooperative Services Authority has been
reviewed and approved by the Cooperative Services Authority Board; now, therefore,

THE ANCHORAGE ASSEMBLY ORDAINS:

Section 1. The fiscal year 2008 Operating Budget of the Anchorage Cooperative
Services Authority (CSA) is hereby adopted.

Section 2. The 2008 Operating Budget fund appropriation for CSA is:

8 21, 2004, establishing the Anchorage Cooperative Services Authority. The stated
9 purpose of the CSA is to assist the municipality and others with whom the municipality
10 or the authority may contract to achieve meaningful and sustainable cost savings on
11 their procured expenses and to improve procurement processes using innovative
12 sourcing techniques supported by a technology capable of growing with the changing
13 needs.

15 CSA continues to provide and maintain efficient purchasing services for the
16 Municipality and others through cooperative purchasing using state-of-the-art
17 technology to purchase and track expenditures for goods and services.

19 The 2008 operating budget for the Cooperative Services Authority has been reviewed
20 and approved by the Cooperative Services Authority Board. No capital budget is
21 proposed for 2008.
