# 27.20.280 Mountain Park/Robin Hill Limited Road Service Area Board of Supervisors.

Pursuant to section 27.10.050, there is established a board of supervisors to administer the Mountain Park/Robin Hill Limited Road Service Area. The board shall consist of <u>five</u> [SIX] members appointed by the mayor and confirmed by the assembly to administer the service area until the regular election of October 1984, at which time the supervisors will be elected for staggered terms. At least one member shall reside in the Sun Valley Heights area. Initial terms of supervisors elected at the regular election of October 1984 shall be selected by lot.
