ANCHORAGE, ALASKA AO NO. 2007–163

AN ORDINANCE SUBMITTING TO THE QUALIFIED VOTERS RESIDING IN THE BIRCH TREE/ELMORE LIMITED ROAD SERVICE AREA AT THE REGULAR MUNICIPAL ELECTION APRIL 1, 2008, A BALLOT PROPOSITION APPROVING THE CONTINUATION OF THE LIMITED ROAD SERVICE AREA UNTIL ALTERED OR ABOLISHED BY MAJORITY VOTE OF THOSE VOTING WITHIN THE AFFECTED AREA, AND AMENDING ANCHORAGE MUNICIPAL CODE SECTION 27.30.290 ACCORDINGLY.

WHEREAS the Birch Tree/Elmore Road Limited Road Service Area was created by Anchorage Ordinance 81-117; and

WHEREAS, a showing of interest by persons residing in the limited road service area (LRSA) to continue the LRSA beyond December 31, 2008, has been made to the Municipality; and

WHEREAS, at every regular election subsequent to its formation and prior to the next termination date, a majority of the qualified voters residing in this LRSA have answered in the affirmative to a ballot proposition to continue its existence for three more years; and

WHEREAS, conducting an election to avoid terminating a limited road service area every three years is costly and should be made unnecessary when there is no grassroots citizen initiative to alter or abolish the limited road service area; now, therefore,

THE ANCHORAGE ASSEMBLY ORDAINS:

 <u>Section 1.</u> A ballot proposition in substantially the following form shall be submitted to the qualified voters residing in the Birch Tree/Elmore Road Limited Road Service Area at the regular Municipal election on April 1, 2008:

<u>Section 2.</u> Anchorage Municipal Code section 27.30.290 is amended to read as follows:

27.30.290 Birch Tree/Elmore Limited Road Service Area.

- A. There is a limited road service area within the municipality known as the Birch Tree/Elmore Limited Road Service Area to provide limited road maintenance and repair to the area described on the map located in Section 27.30.700.
- B. Limited road maintenance and repair within the service area shall continue in existence until altered or abolished [COMMENCE ON JANUARY 2, 1982, AND SHALL END ON DECEMBER 31, 2008, UNLESS THE SERVICE AREA IS EXTENDED] by an affirmative vote in the area affected at an election held prior to alteration or abolishment of the service area [THE REGULAR ELECTION OF APRIL 2008]. The mill rate for the service area shall not exceed 1.5 mills in any calendar year.

<u>Section 3.</u> Except Section 2, this ordinance shall become effective upon passage and approval. Section 2 and the proposition contained in Section 1 shall become effective upon certification of the regular election on the proposition called for by this ordinance, but only if the proposition is approved by a majority of the qualified voters voting on the proposition.
