9 THE ANCHORAGE ASSEMBLY RESOLVES:

11 Section 1. That the sum of FORTY EIGHT THOUSAND SEVEN HUNDRED NINETY FIVE
12 DOLLARS (\$48,795), is appropriated from the State of Alaska, Department of Transportation & Public
13 Facilities to the State Categorical Grants Fund (231), Anchorage Police Department, for Impaired
14 Driving Holiday Blitz Enforcement Program.

16 Section 2. That the sum of ONE THOUSAND DOLLARS (\$1,000), is reappropriated from the
17 State Categorical grants Fund (231), 2006 Drug Recognition Expert Training Grant to the State
18 Categorical Grants Fund (231), Anchorage Police Department.

Subject: Appropriation from the State of Alaska, Department of Transportation & Public Facilities, of an Impaired Driving Holiday Blitz Enforcement Program Grant and local match required. (\$49,795)

The Municipality of Anchorage has received a grant from the State of Alaska, Department of Transportation & Public Facilities, in the amount of \$48,795 for a Holiday Blitz DUI Impaired Driving Enforcement Grant Program. This grant will be used to support enforcement during the period October 1, 2006 through January 3, 2007.

This grant will be used to pay officer overtime for traffic assignments specifically targeted for enforcement of Impaired Driving violations within the Municipality of Anchorage. Through increased awareness and enforcement of Impaired Driving offenses, the citizens of Anchorage will experience safer roads and reduced traffic accident injuries.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$1,000, which is reappropriated from excess contributions from the 2006 Drug Recognition Expert Training Grant. This grant began on October 1, 2006 and will end on January 3, 2007.
