The Municipality of Anchorage has received a grant from the State of Alaska, Department of Transportation & Public Facilities, in the amount of \$40,872 for a Holiday Blitz Seat Belt Enforcement Program. This grant will be used to support enforcement during the period October 1, 2006 through January 3, 2007.

This grant will be used to pay officer overtime for traffic assignments specifically targeted for enforcement of seat belt violations within the Municipality of Anchorage. Through increased awareness and enforcement of seat belt offenses, the citizens of Anchorage will experience safer roads and reduced traffic accident injuries.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$840, which is reappropriated from excess contributions from the 2006 Drug Recognition Expert Training Grant and 2004 Commercial Vehicle Inspection Grant. This grant began on October 1, 2006 and will end on January 3, 2007.
