10 Girdwood Community Center and Library construction project.



3 Subject: Appropriation of ONE MILLION DOLLARS (\$1,000,000) as a grant from
4 the Denali Commission to the Areawide General CIP fund (401) for the
5 Girdwood Community Center and Library.

8 The attached resolution appropriates \$1,000,000 as a grant from the Denali Commission for
9 construction of the new Girdwood Community Center and Library. In 1995, the Assembly
10 adopted the Girdwood Area Plan that identified the development of a joint-use, multi-
11 purpose community center as a community goal. It also identified the need for a re-located
12 library and community center as "immediate" in the implementation schedule for the Plan.
13

14 The new 9,394 square foot addition to the existing fire hall will provide for a 2,534 square
15 foot community meeting room, a 3,938 square foot public library, and a 396 square foot
16 office space for the Girdwood Board of Supervisors. There will also be a large common
17 space area and retrofits to the fire hall.
18

19 The Center and Library will provide a comprehensive benefit to Girdwood, impacting public
20 safety, health, education, civics and the arts. Girdwood is frequently the base for search and
21 rescue operations in the Chugach State Park. The new facility will enable Girdwood to set
22 up a well-equipped command center for rescue operations and other emergencies. The fire
23 department will finally have adequate classroom space to train volunteer firefighters and
24 emergency medical technicians.

26 Through local, state, and federal funding, the Municipality of Anchorage has secured the
27 \$4.5 million needed to construct the facility. In addition, the Municipality has secured a
28 \$514,449 grant from the Rasmuson Foundation to help furnish and equip the library and
29 community center. A local fundraising effort is also underway to raise additional funds for
30 collection enhancement and furnishings.
