The Port of Anchorage anticipates 2007 operating expenditures in excess of the Port Operating budget reflected in the 2007 Approved Utility Operating Budgets (AO 2006-133 approved 10-31-06). Increased anticipated 2007 Port operating expenditures are the result of the following:

American Association of Port Authorities 2008 Convention

In 2008, the Port of Anchorage will be hosting the 97th American Association of Port Authorities Annual Convention from September 21 through September 27, 2008. As host, the Port is responsible for the general management and overall financial support for the convention, planning and organizing the convention's food and beverage, social and entertainment activities, all registration procedures, and local transportation requirements, as well as audio visual support and security.

To assist the Port's convention team in producing a successful convention, the Port will enlist the aid of the Anchorage Convention and Visitors Bureau (ACVB). To compliment the ACVB, the Port proposes to enter into a two-year contract with a professional events planner who, subject to the review and approval of the Port, will plan and organize the integral parts of the convention. The events planner will bring experience and expertise to the convention team to ensure all facets and details of hosting a convention are executed professionally. The contract is expected to begin in January of 2007 and terminate with the completion of the convention, September 2008. The competitively solicited contract will increase the 2007 Operating Budget by \$15,000. The remaining \$28,058 will be submitted in the 2008 budget.

Additionally, the Port is required to host a "promotional" reception at the 2007 AAPA Convention in Norfolk, Virginia. With the assistance of the Events Planner, and in concert with the ACVB, proposals from several venues in Norfolk will be solicited to host the dinner reception with Alaskan entertainment. The estimated amount to host the "promotional" reception is \$135,000.
