A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING THE SUM OF SIXTY THREE THOUSAND ONE HUNDRED TWENTY EIGHT DOLLARS (\$63,128) FROM THE DEPARTMENT OF JUSTICE, COMMUNITY CAPACITY DEVELOPMENT OFFICE, WEED & SEED SITE OFFICE, ANCHORAGE COMMUNITY LAND TRUST AND ONE THOUSAND THREE HUNDRED TEN DOLLARS (\$1,310) AS A CONTRIBUTION FROM THE 2006 ANCHORAGE POLICE OPERATING BUDGET, ANCHORAGE METROPOLITAN POLICE SERVICE AREA FUND (151) TO THE FEDERAL CATEGORICAL GRANTS FUND (241) ANCHORAGE POLICE DEPARTMENT, FOR THIS WEED & SEED PROGRAM COORDINATION GRANT.

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That the sum of SIXTY THREE THOUSAND ONE HUNDRED TWENTY EIGHT DOLLARS (\$63,128), is appropriated from the Department of Justice, Community Capacity Development Office, Weed & Seed Site Office, Anchorage Community Land Trust to the Federal Categorical Grants Fund (241), Anchorage Police Department, for a Weed & Seed program coordination grant..

Section 2. That the sum of ONE THOUSAND THREE HUNDRED TEN DOLLARS (\$1,310), is appropriated from the Anchorage Metropolitan Police Service Area Fund (151), 2006 Anchorage Police Department Operating Budget as a contribution to the Federal Categorical Grants Fund (241), Anchorage Police Department.

Section 3. This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

Subject: Appropriation from the Department of Justice, Community Capacity Development Office, Weed & Seed Site Office, Anchorage Community Land Trust of a Weed & Seed Program Coordination Grant and local match required. (\$64,438)

The Municipality of Anchorage has received a grant from the Department of Justice, Community Capacity Development Office, Weed & Seed Site Office for a Weed & Seed Coordination Program. The Mountain View Weed & Seed Site Office has received a federal grant to reduce the occurrence of violent and drug related criminal activities in the subject area. One of the identified problems sought to be addressed by this pass-through grant is the infrequency of prioritized sworn officer patrols in this relative high crime area.

This grant funding will be used to reimburse sworn officer overtime up to 933 hours immediately through December 31, 2006. This grant will provide increased, focused overtime patrol efforts to reduce gun violence and illegal drug operations in the South Mountain View program site area. The increased presence of patrol officers in and around these targeted housing areas will deter violent or drug related criminal activities while offering the residents an increased sense of security and safety.

A special condition of this grant agreement is that the department provides matching funds. The total projected Municipal cost is \$1,310, which has been budgeted in the 2006 Police Operating Budget. This grant began November 1, 2006 and ended on December 31, 2006.
