1 A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY STATING ITS
2 TEMPORARY NON-OBJECTION TO TRANSFER OF A BEVERAGE DISPENSARY
3 LICENSE FROM THE CURRENT LICENSEE WOODROW & CHONG SANDERS D/B/A
4 ANNA'S PLACE, LOCATED AT 3313 SPENARD ROAD, TO LICENSEE TEMPURA
5 KITCHEN LLC, D/B/A TEMPURA KITCHEN, LOCATED AT 3826 SPENARD ROAD.

7 WHEREAS, Tempura Kitchen LLC has made application with the Alcoholic Beverage
8 Control Board and has paid the required fee for a Transfer Liquor License; and
9

10 WHEREAS, the Anchorage Municipal Clerk received a copy of this application on
11 January 19, 2007, and has determined that the last day for the Assembly to protest transfer
12 of the liquor license is March 23, 2007; and
13

14 WHEREAS, the requisite research, review and Assembly protest process will proceed
15 and this matter will be scheduled for public hearing; and
16

17 WHEREAS, this application is for the transfer of Beverage Dispensary License #3571,
18 currently in use at Anna's Place, 3313 Spenard Road, Anchorage, Alaska; and

20 WHEREAS, the current owner of License #3571 is Woodrow & Chong Sanders of
21 9320 Copper Drive, Anchorage, Alaska 99507; and

23 WHEREAS, the license is to be transferred to a new limited liability corporation,
24 Tempura Kitchen LLC, Registered Agent Woody Sanders, 9320 Copper Drive, Anchorage,
25 Alaska 99507; and

27 WHEREAS, this transfer of liquor license basically represents the wishes of Beverage
28 Dispensary Licensees Woody and Chong Sanders, d/b/a Anna's place at 3313 Spenard
29 Road, to relocate food and beverage service to a new restaurant location, owned by a new
30 limited liability corporation, Tempura Kitchen, LLC, d/b/a Tempura Kitchen at 3826 Spenard
31 Road; and

33 WHEREAS, the owners of Tempura Kitchen LLC wish to use Beverage Dispensary
34 License #3571 immediately, prior to public hearing before the Assembly and elapse of the
35 sixty-day protest deadline;

37 NOW, THEREFORE, the Anchorage Assembly RESOLVES:

1 Section 1. The Anchorage Assembly states its temporary non-objection to transfer
2 of Beverage Dispensary License # 3571 from its current location at 3313 Spenard Road d/b/a
3 Anna's Place to a new location at 3826 Spenard Road, d/b/a Tempura Kitchen, under a
4 limited liability corporation of the same beverage dispensary license owners, Tempura
5 Kitchen LLC; and


7 Section 2. This temporary non-objection is not intended and shall not be used to
8 bind the Assembly to any future action on the transfer of this liquor license, including without
9 limitation, action by the Assembly within the protest period.

11 Section 3. A copy of this resolution may be presented to the Alcoholic Beverage
12 Control Board as proof that the Anchorage Assembly, as the local governing body, has stated
13 its temporary non-objection to the transfer of a Beverage Dispensary License, in order to
14 permit the Director of the Alcoholic Beverage Control Board to issue temporary approval of
15 the license.
