Provision of a Child Care Eligibility Assistance Program

The Department of Health and Human Services has received a supplemental grant award from the Alaska Department of Health and Social Services in the amount of Five Hundred Sixty Thousand Dollars (\$560,000). Initial award of \$515,000 for the time period July 1, 2006 to December 31, 2006 has been appropriated by AR 2006-220. This supplemental award is for the period January 1, 2007 to June 30, 2007 and comprises the total funding of \$1,075,000 for the State fiscal year 2007.

Under the terms of the grant, the Municipal Department of Health and Human Services staff will determine child care subsidies for low to moderate income residents of the Municipality who are employed and/or participating in a training or educational program. Subsidies are based on family size and income using a sliding fee scale. Subsidies are paid by the State for eligible families to State or Municipal licensed agencies, federally approved facilities and authorized child care providers.

Parents who become ineligible for Alaska Temporary Assistance Program benefits because they are now working receive first priority for child care assistance. Eligibility requirements are set by the State of Alaska, Department of Health and Social Services while the Municipal Child Care Eligibility Assistance Program determines level of assistance. This program requires some level of financial contribution by each parent or guardian. The average number of families served per month is 2,040 with 3,010 children.

Services provided by staff include: child and family case management;, counseling;, information and referral;, coordination with the State Child Care Programs Office and Municipal Child/Adult Care Licensing to maintain a database of over 2000 child care providers;, approving caregivers to provideprovider care in the parent's home; training providers on program requirements and billings;, monitoring billings and authorized services;, and collecting statistics for the State.
