10 **THE ANCHORAGE ASSEMBLY RESOLVES:**

12 **Section 1.** That the sum of Forty One Thousand One Hundred Forty Five Dollars (\$41,145) be  
13 appropriated from the Department of Military and Veterans' Affairs, Division Of Homeland Security and  
14 Emergency Management to the State Categorical Grants Fund (231), Office of Emergency Management  
15 for Citizen Corps Program (CCP) activities.



18 Fund (101) Municipal Manager's Department, Office of Emergency Management is appropriated as a

20 the Municipality of Anchorage Citizen Corps Program (CCP) activities.

**Subject:** Appropriation of \$41,145 from the Department of Military and Veterans' Affairs, Division of Homeland Security and Emergency Management and a contribution from the Municipality of Anchorage, Municipal Manager's Department, Office of Emergency Management to support the Anchorage Citizen Corps Program (CCP).

The Citizen Corps Program is a national initiative developed to encourage volunteerism and to link volunteer efforts with public safety programs. The Department of Homeland Security administers Citizen Corps Programs and provides funding to states to foster state and local Citizen Corps Programs such as Volunteers in Police Services (VIPS), Neighborhood Crime Watch and Medical Reserve Corps.

The Office of Emergency Management oversees the administration of the Emergency Watch and Anchorage Citizen Police Academy volunteer programs. In addition, the staff to the Municipal Manager's Office has served as the key contact for all Citizen Corps Programs to date.

The 2006 Homeland Security Grant Program grant will enable the Municipality of Anchorage to link these local efforts (Emergency Watch and Anchorage Citizen Police Academy) more effectively with the national Citizen Corps initiatives in order to provide a comprehensive emergency preparedness program for individuals, families and neighborhoods.

Grant performance period is September 1, 2006 through December 31, 2007.
