A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING THIRTY SEVEN THOUSAND SEVEN HUNDRED TWENTY EIGHT DOLLARS (\$37,728) FROM THE STATE OF ALASKA, DEPARTMENT OF TRANSPORTATION & PUBLIC FACILITIES; AND REAPPROPRIATING TWO HUNDRED NINETY THREE DOLLARS (\$293) OF CONTRIBUTIONS FROM THE 2004 COMMERCIAL VEHICLE INSPECTION GRANT, STATE CATEGORICAL GRANTS FUND (231) AND FOUR HUNDRED SEVENTY SEVEN DOLLARS (\$477) AS A CONTRIBUTION FROM THE 2007 ANCHORAGE POLICE OPERATING BUDGET, ANCHORAGE METROPOLITAN POLICE SERVICE AREA FUND (151) TO THE STATE CATEGORICAL GRANTS FUND (231) ANCHORAGE POLICE DEPARTMENT, FOR SEAT BELT VIOLATION ENFORCEMENT.


THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That THIRTY SEVEN THOUSAND SEVEN HUNDRED TWENTY EIGHT DOLLARS (\$37,728), is appropriated from the State of Alaska, Department of Transportation & Public Facilities to the State Categorical Grants Fund (231), Anchorage Police Department, for Seat Belt Violation Enforcement.

Section 2. That TWO HUNDRED NINETY THREE DOLLARS (\$293) is reappropriated from the State Categorical Grants Fund (231), 2004 Commercial Vehicle Inspection Grant and FOUR HUNDRED SEVENTY SEVEN DOLLARS (\$477), is appropriated from the Anchorage Metropolitan Police Service Area Fund (151), 2007 Anchorage Police Department Operating Budget as a contribution to the State Categorical Grants Fund (231), Anchorage Police Department.

Section 3. This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

**Subject:** Appropriation from the State of Alaska, Department of Transportation & Public Facilities, of a Seat Belt Violation Enforcement Program Grant and local match required. (\$38,498)

The Municipality of Anchorage has received a grant from the State of Alaska, Department of Transportation & Public Facilities, in the amount of \$37,728 for a Seat Belt Violation Enforcement program. This grant is intended to support focused enforcement during the period January 4, 2007 through March 31, 2007.

This grant will be used to pay officer overtime for traffic assignments specifically targeted for enforcement of Seat Belt violations within the Municipality of Anchorage. Through increased awareness and enforcement of Seat Belt offenses, the citizens of Anchorage will experience safer roads and reduced traffic accident injuries.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$770, which was overfunded in the 2004 Commercial Vehicle Inspection Grant and has been budgeted in the 2007 Police Operating Budget. This program grant is being presented for appropriation after the start of the actual performance period due to a delay in grant award from the State of Alaska. This grant began on January 4, 2007 and will end on March 31, 2007.
