The Municipal Code grants a seven-day grace period after the tax due date before any penalty is added to the tax. Tax bills are mailed to owners of record 30 days before the due date. AR NO. 2007- 86 establishes the due dates for payment of first and second installments for the 2007 real property taxes as June 15, 2007 and August 15, 2007, respectively, and the delinquent dates as June 16, 2007 and August 16, 2007 respectively.
