

THE ANCHORAGE ASSEMBLY RESOLVES:



Annually, the Girdwood Board of Supervisors approves an operating budget appropriation of mill levy revenues as a contribution towards the purchase of new fire apparatus. For budget year 2006, a total of \$72,060 was transferred as revenue to the Girdwood Fire Apparatus Capital Improvement Fund (406). The attached AR appropriates the contributed revenue from within Fund 406 so that it may be expended for the capital purchase of new fire apparatus.
