THE ANCHORAGE ASSEMBLY RESOLVES:


**Section 1.** That a grant not to exceed SEVENTY THOUSAND, SEVEN HUNDRED,

**SUBJECT:** APPROPRIATION OF A GRANT TOTALING SEVENTY THOUSAND, SEVEN HUNDRED, FORTY-FIVE DOLLARS (\$70,745) FROM THE STATE LIBRARY TO THE STATE CATEGORICAL GRANT FUND (231) FOR THE READY TO READ PHASE I PROGRAM.

Notification has been received that the Anchorage Municipal Libraries have been awarded a SEVENTY THOUSAND, SEVEN HUNDRED, FORTY-FIVE dollar (\$70,745) grant by the State Library. This amount is appropriated to the State Categorical Grant Fund (231) for The Ready to Read Phase I program for the period of July 1, 2006 to September 30, 2007.

The Ready to Read Phase I program aims to provide services to parents and libraries targeted at youth age 3 and under and pay for a part-time temporary librarian to select and organize these reading materials. These grant funds will be used to purchase reading tubs and materials, Lapsit thematic bags, Read To Me At Home kits, supplies, travel for 3 advisory board members and pay wages for the employee working on the project.
