A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE, ALASKA, APPROVING THE GIRDWOOD PLACE WATER EXTENSION AND PROVIDING FOR ASSESSMENT OF BENEFITED PROPERTIES AT TIME OF SERVICE CONNECTION.

WHEREAS, Alaska State Statute 42.05.385 and AMC 19.90 mandate that when a water line extension will create, or has the potential of creating, any charge or assessment against the adjacent property, the water line extension may not be constructed unless the legislative body of each municipality through which the extension passes has approved the extension.

WHEREAS, the Anchorage Water and Wastewater Utility (AWWU) plans to construct a 16-inch water transmission main on Girdwood Place extending west to Alyeska Highway.

WHEREAS, the extension of the water line will specially benefit and provide water service to one (1) property previously not benefited, and in doing so will create potential assessments against them.

THE ANCHORAGE ASSEMBLY RESOLVES:

SECTION 1. It is in the best interest of the community that said water main improvement proceed.

SECTION 2. AWWU shall keep an accurate account of all costs of the water main improvements.

SECTION 3. After the water main improvements have been completed and the costs of the water line approved, the Mayor shall cause the computation of all applicable assessment charges.

<u>SECTION 4.</u> At such time as the property cited on the attached assessment roll connects to the water main, the respective pro-rata assessment for the water line shall be levied in accordance with Municipal Codes and the AWWU Water Utility Tariff in effect at the time.

<u>SECTION 5.</u> A special assessment Collection Charge, as authorized in Rules Section 13.4 and 15.1 of the Water Utility Tariff, in effect at the time the assessment is levied, will be charged to those properties identified in this resolution.







Subject: Approval of the Girdwood Place Water Extension and Providing for

Assessment of Benefiting Properties at Time of Service Connection

The Anchorage Water & Wastewater Utility (AWWU) plans to construct a 16-inch water transmission main on Girdwood Place extending west then south to Alyeska Highway. In doing so, will make water service available to one (1) parcel. The construction of this main is in conjunction with the MOA-FTA Girdwood Transportation Park & Ride Project.

AMC 19.90 and A.S. 42.05.385 require the Assembly's approval to construct a main extension where the extension will create any charges or assessments against the adjacent properties. A public hearing is not required prior to Assembly action per AMC 19.90.010.B.4. Only one property is provided the potential benefit of water service due to the water main extension. The owner of the benefited property was notified of the estimated project costs, and the estimated cost allocation. The owner was offered the opportunity to meet with AWWU individually for further information and discussions. The property owner has signed an affidavit supporting approval of the project, thereby negating the requirement for public hearing on the project.

The total water main extension project costs will initially be borne by AWWU. When the newly benefited and previously unassessed parcel connects to the water main, AWWU shall recover a portion of the costs through the Levy Upon Connection assessment procedures as authorized by the current Municipal Codes and Utility Tariff.

The property benefiting from the proposed construction is identified on the assessment roll which is made part of the resolution carried by this memorandum. As the property seeks connection, the parcel's pro-rated share of assessable water main costs will be presented to the Assembly for levy confirmation and approval.

The passage of this resolution will have a fiscal impact on one (1) Municipal owned parcel.
