The Municipality of Anchorage has received a grant from the State of Alaska, Department of Transportation & Public Facilities, in the amount of \$37,728 for a Seat Belt Vilation Enforcement program. This grant is intended to support focused enforcement during the period April 1, 2007 through June 30, 2007.

This grant will be used to pay officer overtime for traffic assignments specifically targeted for enforcement of Seat Belt violations within the Municipality of Anchorage. Through increased awareness and enforcement of Seat Belt offenses, the citizens of Anchorage will experience safer roads and reduced traffic accident injuries.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$696, which has been budgeted in the 2007 Police Operating Budget.
