THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That SEVENTY SIX THOUSAND FOUR HUNDRED SEVENTY SIX DOLLARS (\$76,476) be appropriated from the Federal Seized and Forfeited Monies, short term interest for use by the Anchorage Police Investigation Fund (257).

Section 2. That FORTY TWO THOUSAND NINE HUNDRED EIGHTY ONE DOLLARS (\$42,981) be appropriated from the State Seized and Forfeited Monies, reimbursed cost for use by the Anchorage Police Investigation Fund (257).

Section 3. That THIRTY ONE THOUSAND TWO HUNDRED FORTY SEVEN DOLLARS (\$31,247) be appropriated from the Street Level Seized and Forfeited Monies, reimbursed cost for use by the Anchorage Police Investigation Fund (257).

Section 4. That THIRTEEN THOUSAND FOUR HUNDRED TWENTY ONE DOLLARS (\$13,421) be appropriated from the Federal Seized and Forfeited Monies, reimbursed cost for use by the Anchorage Police Investigation Fund (257).

Section 5. That TWO HUNDRED EIGHTY THOUSAND THREE HUNDRED SEVENTY FIVE DOLLARS (\$280,375) be appropriated from the Federal Seized and Forfeited Monies, other fines and forfeitures for use by the Anchorage Police Investigation Fund (257).

<u>Section 6.</u> This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

The Anchorage Police Department requests appropriation of the sum of FOUR HUNDRED FORTY FOUR THOUSAND FIVE HUNDRED DOLLARS (\$444,500) to the Police Investigation Fund (257). This sum is from seized and forfeited monies, short term accrued interest, and reimbursed costs that have been awarded to the Anchorage Police Department by the U.S. Drug Enforcement Agency (DEA) through state and federal judicial proceedings as a result of joint DEA and Anchorage Police narcotics interdiction operations.

The United States Attorney General is authorized under asset forfeiture provisions of the Comprehensive Crime Control Act of 1984, the Anti-Drug Abuse Act of 1986, Title 21 of the United States Code, and the Tariff Act of 1930 to transfer forfeited property. The transfer must be to local law enforcement agencies that participate directly in seizure or forfeiture of the property. The Attorney General exercises final authority over the official retention and transfer of forfeited property to local law enforcement and establishes the guidelines and limitations for its use.
