A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING AN AMOUNT NOT TO EXCEED FOUR HUNDRED SEVEN THOUSAND FIVE HUNDRED TEN DOLLARS (\$407,510) FROM THE CHUGIAK FIRE SERVICE AREA FUND BALANCE (104), THROUGH THE ANCHORAGE FIRE DEPARTMENT CHUGIAK FIRE 2007 OPERATING BUDGET, AS A CONTRIBUTION TO THE CHUGIAK FIRE SERVICE AREA CAPITAL IMPROVEMENT FUND (404), ANCHORAGE FIRE DEPARTMENT, TO PURCHASE A NEW EMERGENCY RESPONSE FIRE APPARATUS FOR THE CHUGIAK VOLUNTEER FIRE DEPARTMENT.

THE ANCHORGE ASSEMBLY RESOLVES:

<u>Section 1:</u> That an amount not to exceed Four Hundred Seven Thousand Five Hundred Ten Dollars (\$407,510) is appropriated from the Chugiak Fire Service Area Fund Balance (104), Anchorage Fire Department, to the Chugiak Fire Service Area Fund (104), Anchorage Fire Department Chugiak Fire 2007 Operating Budget, as a contribution to the Chugiak Fire Service Area Capital Improvement Fund (404).

Section 2: That a contribution in an amount not to exceed Four Hundred Seven Thousand Five Hundred Ten Dollars (\$407,510) from the Chugiak Fire Service Area Fund (104), Anchorage Fire Department, is appropriated to the Chugiak Fire Service Area Capital Fund (404), Anchorage Fire Department, to purchase a new emergency response apparatus for the Chugiak Volunteer Fire Department.

<u>Section 3:</u> That this Resolution shall become effective immediately upon passage and approval by the Anchorage Municipal Assembly.

Funds to make these purchases are drawn, as the need arises, from accumulated operating budget surpluses which accrue to the Chugiak Fire Service Area Fund (104) Balance.

This appropriation provides for the purchase of a new Pumper/Tender for use by the Chugiak Volunteer Fire Department. The associated written request and authorization received on May 17, 2007 from the Chugiak Fire Service Area Board of Supervisors confirmed that this new apparatus will be assigned to the Chugiak Volunteer Fire Department's newest facility, Fire Station 35.
