In April 2004, voters from the Eagle River-Chugiak Parks and Recreation Service Area approved a new \$0.50 mill rate to generate annual capital funds for parks and recreation. This mill rate will generate \$1,639,870 in 2007. These revenues are being collected and deposited into the Eagle River-Chugiak Parks and Recreation Service Area Fund (162) to be contributed to the Eagle River-Chugiak Parks and Recreation Service Area Capital Improvement Project Fund (462) for capital maintenance and improvements.

AR2007-50 appropriated \$1,441,220 from the operating fund (162) as a contribution to the Eagle River-Chugiak Parks and Recreation Service Area Capital Improvement Project Fund (462) based on preliminary assessed valuation estimates available at the time of the adopted 2007 budget.

The attached resolution appropriates an additional \$198,650 contribution approved in the 2007 General Operating Budget for a total contribution of \$1,639,870 from the Eagle River-Chugiak Parks and Recreation Service Area Fund (162) to the Eagle River-Chugiak Parks and Recreation Service Area Capital Improvement Project Fund (462) reflecting the 2007 final 1st quarter assessed valuations.
