A RESOLUTION CONFIRMING THE ASSESSMENT ROLL AND LEVYING SPECIAL ASSESSMENTS FOR SERVICES ON PROPERTY SPECIALLY BENEFITED IN THE DOWNTOWN BUSINESS IMPROVEMENT DISTRICT, SPECIAL ASSESSMENT DISTRICT 1SD97, SETTING THE DATES OF ASSESSMENT, AND PROVIDING FOR ASSESSMENT BILLING, PAYMENT DUE DATES, APPLICATION OF PAYMENTS, DELINQUENCY, PENALTIES, INTEREST AND COSTS FOR DELINQUENCY AND ENFORCEMENT AND APPROPRIATING THE SUM OF TWENTY SEVEN THOUSAND SEVENTEEN DOLLARS (\$27,017) IN ASSESSMENT REVENUES WHEN TENDERED TO SPECIAL ASSESSMENT FUND 271 FOR SERVICES BENEFITING THE PROPERTY OWNERS IN SPECIAL ASSESSMENT DISTRICT 1SD97

THE ANCHORAGE ASSEMBLY HEREBY RESOLVES:

Section 1. The services authorized in Anchorage Ordinance No. 2000-98 extending the Downtown Business Improvement District, Special assessment District 1SD97, (herein "Services") are hereby levied against the properties, lots and tracts specially benefited as set forth in the attached Assessment Roll for Special Assessment District 1SD97 (herein the "Assessment Roll").

Section 2. Timely notice was sent to each property owner whose property is specially benefited by the Services as indicated on the Assessment Roll, and each property owner was given notice of a public hearing before the Assembly for the purpose of providing property owners an opportunity to present objections to the Assessment Roll by showing errors and inequalities and by submitting any reason for amending or correcting the Assessment Roll for Special Assessment District 1SD97.

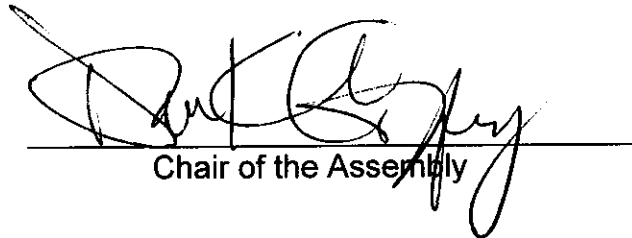
Section 3. In conformity with the notice to the property owners, the Assembly held a hearing on **AR No. 2007-174** to hear objections by affected property owners to the Assessment Roll. At said hearing, all errors and inequalities to which valid objections were raised, if any, were corrected and the assessed properties and assessment amounts now indicated on the Assessment Roll are and shall be the assessed properties and the annual assessment amounts finally determined to be the properties and assessment and that assessment amounts are fairly proportionate to the special benefit to each property accruing from the services to be provided in Special Assessment District 1SD97. The Assessment Roll has been duly certified by the Clerk. Special assessments are hereby levied against the properties, lots and tracts specially benefited by the said services as set forth in the attached Assessment Roll.

Section 4. The Municipal Treasurer shall mail, postage prepaid, an assessment bill to each property owner shown on the Assessment Roll in accordance with Anchorage Ordinance No. 2000-98. Assessments shall be due, payable and delinquent, shall bear penalties, interest and costs and the application of payments on and enforcement of assessments shall be as prescribed in Anchorage Ordinance No. 2000-98.

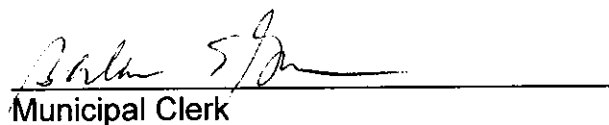
Section 5. The Assessment Roll hereby established may be recorded with the District Recorder for the Anchorage Recording District, Third Judicial District, State of Alaska as appended hereto or showing only the property description and amount of assessment without the names of the property owners.

Section 6. That the sum of Twenty Seven Thousand Seventeen Dollars (\$27,017) of Special Assessment District 1SD97 assessment revenues is hereby appropriated to Fund 271 for payment of services benefiting the property owners of said assessment district.

7 DOLLARS (\$27,017) OF SPECIAL ASSESSMENT REVENUE TO FUND
8 271 FOR SPECIAL ASSESSMENT DISTRICT 1SD97.

10 On June 20, 2000, the Municipal Assembly approved Ordinance AO 2000-98, extending
11 the Downtown Business Improvement District, Special Assessment District 1SD97.
12

13 AO 2000-98 established Special Assessment District 1SD97 for the provision of public
14 services that are in addition to regular Municipal services as authorized under
15 Anchorage Municipal Code section 19.10.020A.2. These services do not reduce or
16 eliminate services otherwise provided by the Municipality.
17

18 AO 2006-130(S) (as amended), adopting and appropriating funds for the 2007
19 (Updated) General Government Operating Budget, appropriated the sum of \$684,000 of
20 anticipated revenues for 2007 services benefiting property owners within Special
21 Assessment District 1SD97. The 2007 Assessment Roll totals \$711,017. The attached
22 resolution appropriates the difference between \$684,000 already appropriated and the
23 Assessment Roll total of \$711,017 for an additional appropriation of \$27,017.
24

25 AR 2007-174 confirms the 2007 assessment roll for the Downtown Business
26 Improvement District (attached) and levies assessments to provide services in 2007.
27 The supplemental services that may be provided include:
28

- 29 • Maintenance, repair and upkeep of public capital improvements located in the areas
- 30 of the Business Improvement District;
- 31 • Maintenance, snow removal, dust suppression, cleaning, beautification, and
- 32 decoration of public parks, places and pedestrian and vehicular rights-of-way;
- 33 • Visitor and tourism services;
- 34 • Security services, but not including law enforcement services;
- 35 • Promotion of the Business Improvement District and public events within the district;
- 36 and
- 37 • Other closely similar public services which promote the vitality, stability and
- 38 improvement of the Business Improvement District.

Subject: ASSESSMENT ROLL FOR BUSINESS IMPROVEMENT DISTRICT 1SD97.

1 Assessments are calculated upon the basis of real property tax valuation for the tax
2 year 2007. The assessment rate is 1.5 mills up to and including \$10,000,000 plus \$100
3 per \$1,000,000 of assessed value in excess of \$10,000,000.
4

5 In accord with AMC 19.20.090, by July 27 a written notice of the public hearing will be
6 sent first-class mail to each owner of property to be assessed within the boundaries of
7 the district.
8

9 Newspaper notice of the public hearing also will be published at least once a week for
10 two consecutive weeks prior to the time fixed for the hearing.
11

12 THE ADMINISTRATION RECOMMENDS APPROVAL OF AR 2007-174, CONFIRMING
13 THE ASSESSMENT ROLL AND LEVYING SPECIAL ASSESSMENTS WITHIN
14 ASSESSMENT DISTRICT 1SD97, THE DOWNTOWN BUSINESS IMPROVEMENT
15 DISTRICT AND APPROPRIATING TWENTY SEVEN THOUSAND SEVENTEEN
16 DOLLARS (\$27,017) OF SPECIAL ASSESSMENT REVENUE TO FUND 271 FOR
