A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING TWO HUNDRED THIRTY TWO THOUSAND THREE HUNDRED THIRTY DOLLARS (\$232,330) FROM THE STATE OF ALASKA, DIVISION OF HOMELAND SECURITY AND EMERGENCY MANAGEMENT, UNDER THE METROPOLITAN MEDICAL RESPONSE SYSTEM (MMRS) GRANT PROGRAM, AND A CONTRIBUTION OF FOUR THOUSAND THREE HUNDRED DOLLARS (\$4,300) FROM THE AREAWIDE GENERAL FUND (101), ANCHORAGE FIRE DEPARTMENT 2007 OPERATING BUDGET, TO THE STATE CATEGORICAL GRANTS FUND (231), ANCHORAGE FIRE DEPARTMENT, TO SUPPORT THE DEPLOYMENT OF AN ELECTRONIC PATIENT CARE REPORTING AND TRACKING SYSTEM, AND RELATED ENHANCEMENTS TO EXISTING BIO-SURVEILLANCE, INCIDENT RESPONSE, AND EMERGENCY INFORMATION MANAGEMENT AND NOTIFICATION CAPABILITIES.

THE ANCHORAGE ASSEMBLY RESOLVES:

**Section 1:** That the sum of Two Hundred Thirty Two Thousand Three Hundred Thirty Dollars (\$232,330) is appropriated from the State of Alaska, Division of Homeland Security and Emergency Management, under the Metropolitan Medical Response System (MMRS) Grant Program, to the State Categorical Grants Fund (231), Anchorage Fire Department, to support the deployment of an electronic patient care reporting and tracking system, and related enhancements to existing bio-surveillance, incident response, and emergency information management and notification capabilities.


**Section 2:** That the sum of Four Thousand Three Hundred Dollars (\$4,300) from the Areawide General Fund (101), Anchorage Fire Department 2007 Operating Budget, is appropriated as a contribution to the State Categorical Grants Fund (231), Anchorage Fire Department, to support the deployment of an electronic patient care reporting and tracking system, and related enhancements to existing bio-surveillance, incident response, and emergency management information and notification capabilities.

**Section 3:** This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

**From:** Mayor

**Subject:** Appropriation of 2006 Metropolitan Medical Response System (MMRS) federal pass-through grant in the amount of \$232,330 received from the State of Alaska, Division of Homeland Security and Emergency Management, and a contribution of \$4,300 from the Anchorage Fire Department 2007 Operating Budget to the State Categorical Grants Fund (231).

The requested appropriation of 2006 Metropolitan Medical Response System (MMRS) federal pass-through grant funds and contributed departmental operating funds will be used to support the Municipality of Anchorage Fire Department's Electronic Patient Care Reporting and Patient Tracking Project, to include the acquisition and deployment of software, professional services, and field deployed laptop computers to improve emergency medical care and documentation.

Approval of the appropriation will also provide additional funding to facilitate enhancements to the Municipality's existing bio-surveillance and related emergency information management and reporting systems, which are designed to alert key personnel of imminent public health threats and events indicative of a potential or actual attack involving the use of weapons of mass destruction (WMD).

The period for performance is September 1, 2006 through December 31, 2007.
