10 THE ANCHORAGE ASSEMBLY RESOLVES:

12 Section 1. That the sum of FOURTEEN THOUSAND EIGHTY EIGHT DOLLARS (\$14,088), is
13 appropriated from the State of Alaska, Department of Transportation & Public Facilities to the State
14 Categorical Grants Fund (231), Anchorage Police Department, for a Drug Recognition Expert Training
15 Conference Program.

17 Section 2. That the sum of FIVE THOUSAND TWO HUNDRED THIRTY DOLLARS (\$5,230), is
18 appropriated from the Anchorage Metropolitan Police Service Area Fund (151), 2007 Anchorage Police
19 Department Operating Budget as a contribution to the State Categorical Grants Fund (231), Anchorage
20 Police Department.

Subject: Appropriation from the State of Alaska, Department of Transportation & Public Facilities, of a Drug Recognition Expert Training Conference Program Grant and local match required. (\$19,318)

The Municipality of Anchorage has received a grant from the State of Alaska, Department of Transportation & Public Facilities for a Drug Recognition Expert Training Conference program. This grant will be used for seven Drug Recognition Expert trained, sworn officers to attend the 13th Annual International Association of the Chiefs of Police Drug Recognition Expert Training Conference during the period July 30, 2007 through August 2, 2007.

This grant will be used to reimburse travel and training costs related to the Drug Recognition Expert Training Conference to be held in Las Vegas, Nevada. This training will allow seven officers to maintain Drug Recognition Expert Certification. With this certification, these officers are able to obtain warrants for chemical blood testing in traffic stops where no signs of alcohol are present. Through increased awareness and enforcement of impaired driving violations, the citizens of Anchorage will experience safer roads and reduced traffic injuries.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$5,230, which has been budgeted in the 2007 Police Operating Budget. This grant began on July 30, 2007 and ended on August 2, 2007.
