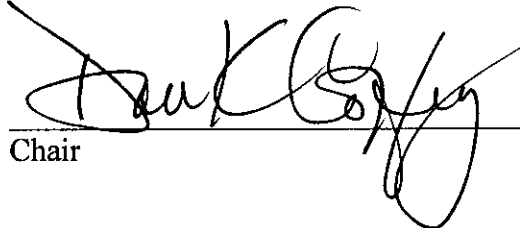

Subject: APPROPRIATION OF TWO HUNDRED THIRTY DOLLARS (\$230) FROM THE STATE OF ALASKA, DEPARTMENT OF COMMERCE, COMMUNITY AND ECONOMIC DEVELOPMENT, TO THE STATE CATEGORICAL GRANT FUND (231) FOR REIMBURSEMENT OF TRAVEL COSTS ASSOCIATED WITH THE ANCHORAGE COASTAL MANAGEMENT PROGRAM.

For the past 26 years, with the endorsement of the Municipal Assembly, the Planning Department has been implementing the Anchorage Coastal Management Program. During this period, the State of Alaska has provided funding to the Municipality for staff support for required Coastal District tasks. The State of Alaska already provided a grant for state fiscal year 2007 to the Municipality of Anchorage in the amount of \$38,500 for work on the coastal management program.

This new appropriation for \$230 is for a grant that reimburses the Municipality for the airfare expense incurred when an Anchorage planner traveled to Juneau in April 2007 to attend the Alaska Coastal Management Program's Statewide Conference. The State of Alaska requires each coastal district to send a person to the statewide conference.
