7 **THE ANCHORAGE ASSEMBLY RESOLVES:**

9 **Section 1.** That the sum of one hundred forty eight thousand dollars (\$148,000) is
10 hereby appropriated as a grant from the Rasmuson Foundation to the Areawide General
11 CIP Fund (401), Office of Economic and Community Development, for the Girdwood
12 Community Center and Library project.

14 **Section 2.** That this resolution shall take effect immediately upon passage and
15 approval by the Anchorage Municipal Assembly.

5 Appropriation of One Hundred Forty Eight Thousand Dollars (\$148,000)
6 as a grant from the Rasmuson Foundation to the Areawide General CIP
7 Fund (401), Office of Economic and Community Development, for the
8 Girdwood Community Center and Library project.

11 The attached resolution appropriates \$148,000 as the second installment of a grant from
12 the Rasmuson Foundation for collections enhancement for the new Girdwood Community
13 Center and Library. In November, 2006 the Rasmuson Foundation approved a grant of
14 \$514,449 for furniture, fixtures and equipment for the Girdwood Community Center and
15 Library. Of this total, \$314,449 has already been awarded and was appropriated on January
16 23, 2007 (AR #2007-11). The remainder of the grant is being provided subject to a 2:1 local
17 match. To date, \$74,000 has been raised in local matching funds.
18

19 In 1995, the Anchorage Assembly adopted the Girdwood Area Plan that identified the
20 development of a joint-use, multi-purpose community center as a community goal. It also
21 identified the need for a re-located library and community center as "immediate" in the
22 implementation schedule for the Plan.
23

24 The new 9,394 square foot addition to the existing fire hall will provide for a 2,534 square
25 foot community meeting room, a 3,938 square foot public library, and a 396 square foot
26 office space for the Girdwood Board of Supervisors. There will also be a large common
27 space area and retrofits to the fire hall.
