## THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That the sum of FOUR HUNDRED TWENTY ONE THOUSAND EIGHT HUNDRED SEVENTY TWO DOLLARS (\$421,872), is appropriated from the U.S. Department of Justice, Office of Justice Programs, Edward Byrne Memorial Justice Assistance Grant to the Federal Categorical Grants Fund (241), Anchorage Police Department for the purpose of underwriting projects to reduce crime and improve public safety.

Edward Byrne Memorial Justice Assistance Grants, authorized by the Crime Identification Technology Act, 1998 (42USC14601), provide local governments with funds to underwrite projects to prevent and control crime based on local needs and conditions. The Municipality of Anchorage has been awarded a grant in the amount of \$421,872 (four hundred twenty-one thousand eight hundred seventy-two dollars) with a required local contribution of \$7,820 (seven thousand eight hundred twenty dollars) for a total program budget of \$429,692 (four hundred twenty-nine thousand six hundred ninety-two dollars). These amounts are requested to be appropriated to the Federal Categorical Grants Fund (241) for use by the Anchorage Police Department. The performance period of this grant is October 1, 2006 to September 30, 2010.
