The Municipality of Anchorage has received a grant from the Alaska Mental Health Trust Authority for a Crisis Intervention Team Training Program. This training has won best practice awards from the U.S. Department of Justice, the White House, and Amnesty International and is offered annually, to law enforcement agencies throughout the State of Alaska.

This grant funding will be used to reimburse overtime for up to fifteen officers of the Anchorage Police Department to attend Crisis Intervention Team Training this year. Through increased law enforcement awareness of issues associated with mental illness, citizens residing in the Municipality of Anchorage will experience a safer living environment.

A special condition of this grant agreement is that the department provides matching funds. The total projected Municipal cost is \$740, which has been budgeted in the 2007 Police Operating Budget. This training will take place in Anchorage, beginning October 1, 2007 and ending on October 5, 2007.
