The Municipality of Anchorage has received a grant from the Alaska Mental Health Trust Authority for attendance at the National Crisis Intervention Team Conference. This is an annual training conference designed to increase the knowledge of mental health disorders and skills for facilitating positive interactions between law enforcement and persons with mental health disorders.

This grant funding will be used to reimburse overtime for up to eight officers of the Anchorage Police Department to attend the National Crisis Intervention Team Conference this year. Through increased law enforcement awareness of issues associated with mental illness, citizens residing in the Municipality of Anchorage will experience a safer living environment.

A special condition of this grant agreement is that the department provides matching funds. The total projected Municipal cost is \$270, which has been budgeted in the 2007 Police Operating Budget. This conference took place in Memphis, Tennesse, beginning August 28, 2007 and ending on Augst 30, 2007. This grant agreement is being presented for appropriation after the actual performance period due to administrative delays with the grantor.
