The attached Assembly Resolution appropriates Nine Thousand Four Hundred Seventy Three Dollars (\$9,473) from the State of Alaska through the State Historic Preservation Officer to fund the Fairview Historic Survey. Buildings older than 50 years old are potentially eligible for the National Historic Register and must be evaluated before federal funds may alter them. The lack of a comprehensive historic survey in Fairview has hindered program administrators when pursuing projects in that area. The purpose of the survey is to identify buildings older than 45 years that may be eligible for the National Historic Register.

These funds represent amendment one on the initial award of Fifteen Thousand One Hundred Twenty Dollars (\$15,120) appropriated through AR-2006-119. The grant period is from April 15, 2006 through September 30, 2007. These funds will augment Community Development Block Grant funds already designated for this purpose in the Housing and Community Development Consolidated Plan's 2006 Action Plan. A match of at least \$19,324 is required to secure the grant. CDBG funds already designated for the Fairview Historic Survey will be used to meet the match requirement.
