1 A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING ONE MILLION
2 ONE HUNDRED FOURTEEN THOUSAND TWO HUNDRED FIFTY SEVEN DOLLARS
3 (\$1,114,257) AS A GRANT FROM THE STATE OF ALASKA, DEPARTMENT OF MILITARY AND
4 VETERANS AFFAIRS, DIVISION OF HOMELAND SECURITY AND EMERGENCY
5 MANAGEMENT AND APPROPRIATING TWENTY THOUSAND SIX HUNDRED FORTY
6 DOLLARS (\$20,640) AS A CONTRIBUTION FROM THE 2007 ANCHORAGE POLICE
7 OPERATING BUDGET, ANCHORAGE METROPOLITAN POLICE SERVICE AREA FUND (151)
8 TO THE STATE CATEGORICAL GRANTS FUND (231), ANCHORAGE POLICE DEPARTMENT,
9 FOR THE PURCHASE OF TERRORISM RESPONSE AND PREVENTION EQUIPMENT.

11 THE ANCHORAGE ASSEMBLY RESOLVES:

13 Section 1. That the sum of ONE MILLION ONE HUNDRED FOURTEEN THOUSAND TWO
14 HUNDRED FIFTY SEVEN DOLLARS (\$1,114,257) is appropriated as a grant from the State of Alaska,
15 Department of Military and Veterans Affairs, Division of Homeland Security and Emergency
16 Management to the State Categorical Grants Fund (231), Anchorage Police Department, for the purchase
17 of terrorism response and prevention equipment.

19 Section 2. That the sum of TWENTY THOUSAND SIX HUNDRED FORTY DOLLARS
20 (\$20,640) is appropriated from the 2007 Anchorage Police Operating Budget, Anchorage Metropolitan
21 Police Service Area Fund (151) as a contribution to the State Categorical Grants Fund (231), Anchorage
22 Police Department, for the purchase of terrorism response and prevention equipment.



Subject: Appropriation of State of Alaska, Department of Military and Veterans Affairs,
Division of Homeland Security and Emergency Management State Homeland
Security Law Enforcement Terrorism Prevention Program Grant (\$1,134,897)

The Municipality of Anchorage, Anchorage Police Department has received from the Office for Domestic Preparedness through the State of Alaska, a grant to enhance security and preparedness for terrorist prevention. Appropriation of grant and required local matching funds is requested to the State Categorical Grants Fund (231).

Grant funds awarded provide for the procurement of specialized terrorism response equipment and interoperable radio system repeaters to be utilized by the Anchorage Police Department.

FY2007 Law Enforcement Terrorism Prevention Program Grant funds will be administered by the Anchorage Police Department. A special condition of this grant is that the department contribute funds to support associated indirect grant costs. The total projected municipal cost is \$20,640 which is funded through a 2007 operating contribution from the Anchorage Metropolitan Police Service Area Fund (151). This grant began on October 1, 2007 and will end on September 30, 2009.
