**Subject:** Alaska Housing Finance Corporation (AHFC) Grant for the Pathways to Sobriety III Project

The Department of Health & Human Services (DHHS) received Seventy-Five Thousand Dollars (\$75,000) to be appropriated as a grant award from AHFC to the State Categorical Grants Fund (231), Department of Health and Human Services for the Pathways to Sobriety III Project. The period of this grant is from August 1, 2007 through June 30, 2008.

DHHS will serve as the lead agency in coordination with Anchorage Community Mental Health Services, undertaking activities and strategies to address the addiction and mental health issues of public enibriates, break the cycle of their repeated uses of the emergency system, and move persons into community reintegration and healthier living practices. The majority of effort will now be directed towards follow-up and stabilization services including re-housing, housing stabilization and supportive housing case management, while still providing limited outreach detoxification and treatment services.
