By deploying automatic defibrillators in active patrol cars, the citizens of Anchorage can enjoy a greater sense of security due to the increased response capabilities of on duty patrol officers. There is no Municipal fund match requirement for this donation. There is no specific time frame for expenditure of donated funds.
