Prevention Grant Award (\$305,516)

The Bureau of Justice Assistance has provided funding under the FY2007 Internet Crimes Against Children Phase II Expansion Program. The Municipality of Anchorage has been awarded a grant in the amount of \$299,956 to establish the Alaska Internet Crimes Against Children Task Force. This grant is intended to support task force establishment and operations among statewide member agencies during the period September 1, 2007 through February 28, 2009.

Grantor approved areas of expenditure in this grant program are as follows:

This grant will provide funding for training and support of associate members of the Alaska Internet Crimes Against Children Task Force to enable them to investigate computer crimes targeted against children. The Alaska ICAC Task Force will conduct public outreach and education of law enforcement agencies, judicial system, and community members on the dangers posed to children by internet predators.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$5,560, which has been budgeted in the 2007 Police Operating Budget. This program grant is being presented for appropriation after the start of the actual performance period due to a delay in grant award from the U.S. Department of Justice. This grant began on September 1, 2007 and will end on February 28, 2009.
