

9 THE ANCHORAGE ASSEMBLY RESOLVES:



Subject: A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING FORTY FOUR THOUSAND ONE HUNDRED DOLLARS (\$44,100) IN PRIVATE-PARTY INSURANCE RECOVERIES TO THE ANCHORAGE FIRE DEPARTMENT, ANCHORAGE FIRE DEPARTMENT 2007 OPERATING BUDGET, GENERAL GOVERNMENT AREAWIDE FUND (101), RECEIVED AS REIMBURSEMENT FOR THE CONTRACTED REPAIR OF AN AMBULANCE DAMAGED IN A VEHICULAR ACCIDENT.

In December 2006, an ambulance assigned to the Gridwood Volunteer Fire Department, Station #41, was severely damaged in a vehicular accident on the New Seward Highway. The Anchorage Fire Department received \$44,100 in private-party insurance proceeds as reimbursement for the contracted repair costs incurred to return this emergency medical response apparatus to full service. The requested appropriation offsets the unanticipated loss of this 2007 operating budget expenditure authority, which was originally appropriated to cover a portion of the annual direct, non-labor costs associated with operating and maintaining the department's fleet of emergency response apparatus.
