Appropriation from the State of Alaska, Department of Transportation & Public Facilities, of a Seat Belt Violation Enforcement Program Grant and local match required. (\$28,816)

The Municipality of Anchorage has received a grant from the State of Alaska, Department of Transportation & Public Facilities, in the amount of \$28,296 for a Seat Belt Vilation Enforcement program. This grant is intended to support focused enforcement during the period October 1, 2007 through December 31, 2007.

This grant will be used to pay officer overtime for traffic assignments specifically targeted for enforcement of Seat Belt violations within the Municipality of Anchorage. Through increased awareness and enforcement of Seat Belt offenses, the citizens of Anchorage will experience safer roads and reduced traffic accident injuries.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$520, which has been budgeted in the 2007 Police Operating Budget. This program grant is being presented for appropriation after the start of the actual performance period due to a delay in grant award from the State of Alaska. This grant began on October 1, 2007 and will end on December 31, 2007.
