The Municipality of Anchorage has received a grant from the State of Alaska, Department of Transportation & Public Facilities, in the amount of \$21,994 for a Law Enforcement Equipment program. This grant is intended to fund the purchase of fifty Portable BreathTesters (DUI) for deployment to the department's patrol division.

This grant will be used to purchase Portable Breath Testers that will be utilized by the patrol division in suspected Driving Under the Influence traffic stops within the Municipality of Anchorage. Through increased awareness and enforcement of Driving Under the Influence violations, the citizens of Anchorage will experience safer roads and reduced traffic accident injuries.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$410, which has been budgeted in the 2007 Police Operating Budget. This program grant is being presented for appropriation after the start of the actual performance period due to a delay in grant award from the State of Alaska.
