The South Goldenview RRSA Board has been holding meetings with residents and the Maintenance and Operations Department regarding the removal of the Goldenview Drive Right-of-Way between Rabbit Creek Road and Bulgaria Drive from the South Goldenview RRSA and annexing the ROW into ARDSA. The meetings discussed the present and future traffic and safety impact on citizens using the road, the main arterial access to the growing residential development in south Anchorage. The residents also addressed the wherewithal and capabilities of ARDSA to bring the Goldenview Drive Right-of-Way and drainage system up to a reasonable hillside standard to reduce annual road and drainage maintenance costs, improve the safety of the streets, upgrade the drainage system and reduce dust conditions. Based on these meetings, the Board requested the removal of the Goldenview Drive Right-of-Way and annexation to ARDSA to begin officially, including any ballot propositions required for the April 1, 2008 general election.
